<p>Article 16 Early Termination of Rental Due to Reasons Attributable to the Renter</p> <p>During the rental term, when it is no longer possible to use the Rental Car due to accidents or malfunctions attributable <u>to the Renter</u> or any other reasons which are attributable, <u>the Renter</u> must inform the Company immediately, and the Rental Agreement shall terminate at the time the Company is informed. Note that, in such case, the Company shall not exempt the Renter from rental fees after the point in time when use of the Rental Car is no longer possible.</p>	<p>Article 16 (Termination of Rental Contract due to Grounds Attributable to the Renter)</p> <p>1. In the event that the rental car cannot be used due to accident, breakdown, or other grounds attributable <u>to the renter or the driver</u> during the rental term, <u>the renter or the driver</u> must immediately notify the Company of the occurrence of said grounds, and the rental agreement shall be terminated at the time that the Company is contacted.</p> <p><u>2. In the event that during the rental period the renter or the driver parks illegally on private property or at other locations and the Company is required by the landowner, the police, etc. to remove the rental car, the Company may remove or collect the rental car when the Company judges that the renter or driver cannot immediately remove the rental car.</u></p> <p><u>3. In the case of the preceding paragraph, the rental agreement shall be terminated at the time that the Company removes or collects the rental car. The Company may claim from the renter or the driver the expenses required to search for and remove or collect the rental car.</u></p> <p><u>4. In the event that the rental agreement is terminated pursuant to paragraph 1 or paragraph 2 above, the Company shall not discharge the renter from the rental fees on and after the time that the use of the rental car becomes impossible.</u></p>
<p>Article 24 Liability for Compensation</p> <p>1. When the Rental Agreement has terminated due to reasons attributable <u>to the Renter in accordance with Article 16</u>, the Renter shall pay the Company fees prescribed separately by the Company as compensation for business during the period during which the Rental Car is being repaired.</p>	<p>Article 24 Liability for Compensation</p> <p>1. When the rental car cannot be used due to accident, breakdown, or <u>other grounds attributable to the renter or the driver during the rental term</u>, the Renter shall pay the Company fees prescribed separately by the Company as compensation for business during the period during which the Rental Car is being repaired.</p>
